### *Social Memberships*

Friends of Twin Lakes      \$40 per month

Membership includes member, spouse, and any children under the age of 22 residing in the home. Friends of Twin Lakes members are entitled to full use of the Club facilities, use of the clubhouse for all social activities, seasonal swimming pool, tennis court, driving range, and additional practice facilities. Access to Swim Team. No food minimums, no charging privileges, no Junior Golf privileges. Allowed 6 rounds of golf per calendar year (ability to pay and play up to one 4-some per round). 12 month minimum commitment, anytime after 12 months member may elect to cancel membership by abiding by the current bylaws and policies. Friends of Twin Lakes Member agrees to pay an early cancellation fee of \$300 if membership is cancelled prior to the 12 month commitment. This membership category is only available to new members, or members who have not had a membership at Twin Lakes Golf & Country Club for the previous 12 months. This category is non-certificate holding and does not include voting rights nor is it subject to assessments.

Social Membership      \$80 per month

Membership includes member, spouse, and any children under the age of 22 residing in the home. Social Members are entitled to full use of the Club facilities for all social activities, use of the clubhouse, seasonal swimming pool, tennis court, and additional practice facilities. Access to Swim Team and Junior Golf. Member will have charging privileges and monthly food minimums. Allowed 12 rounds of golf per calendar year (ability to pay and play up to one 4-some per round). 12 month minimum commitment, anytime after 12 months member may elect to cancel membership by abiding by the current bylaws and policies. This category is non-certificate holding and does not include voting rights nor is it subject to assessments.

### *Golfing Memberships*

Executive Membership      \$225 Individual /month      \$300 Family / month      Initiation Fee \$500

Executive Membership includes unlimited green fees for member. Family membership includes unlimited green fees for spouse and/or children under the age of 22 residing in the home. Additional amenities include use of the clubhouse for all social and golf activities, seasonal swimming pool, tennis court, driving range, and additional practice facilities. Access to Swim Team and Junior Golf. Membership includes charging privileges. 12 month minimum commitment, anytime after the initiation fee is paid in full and member has paid dues for 12 months, member may elect to cancel membership by abiding by the current bylaws and policies. This category is non-certificate holding and does not include voting rights nor is it subject to assessments or food minimums. Opportunity to transfer initiation fee to Proprietary Membership. This membership category is only available to new golfing members, or members who have not had a golfing membership at Twin Lakes Golf & Country Club for the previous 12 months.

Proprietary Membership      \$291 Individual / month      \$388 Family / month      Initiation Fee \$2500\*

Proprietary members hold an equity position and are responsible for leadership and club decisions. Only proprietary members may hold board positions. Individual Proprietary Membership includes unlimited green fees for certificate holding member, Proprietary Membership includes unlimited green fees for spouse and or children under the age of 22 residing in the home. Additional amenities include use of the clubhouse for all social and golf activities, seasonal swimming pool, tennis court, driving range, and additional practice facilities. Access to Swim Team and Junior Golf. Charging privileges, food minimums, and assessments apply. Proprietary members have voting privileges and equity when applicable. 12 month minimum commitment, anytime after the initiation fee is paid in full and member has paid dues for 12 months, member may elect to cancel membership by abiding by the current bylaws and policies.
